4.1. Description of first aid measures

General information	In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Advice for Medical Doctors: Brodifacoum is an indirect anti-coagulant. Phytomenadione, Vitamin K, is antidotal. Determination of prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.
Inhalation	Due to the physical nature of this product, exposure by this route is unlikely. Get medical attention if symptoms are severe or persist.
Ingestion	Rinse mouth thoroughly with water. Do not induce vomiting. Get medical attention immediately.
Skin contact	May cause irritation to susceptible persons. Immediately take off all contaminated clothing. Wash skin thoroughly with soap and water. Get medical attention if symptoms are severe or persist after washing.
Eye contact	May cause eye irritation to susceptible persons. Rinse immediately with plenty of water and seek medical advice.
