

INDICATIONS

Protector Flying and Crawling Insect Killer ensures fast flushing, instant knock-down, sure kill and long lasting residual control of flies, wasps, cockroaches, ants, fleas, moths, bedbugs, lice and all other crawling insects.

DIRECTIONS FOR USE

Application rate: Spray directly on to surfaces. A 4-5 second burst suitable for 1 square metre or 2-4 linear metres of skirting board. To flush insects out, spray hiding places from 5 cm and then spray crawling insects directly for rapid kill. For several weeks of effective residual control, spray from 30 cm until wet onto surfaces where insects crawl or hide. Concentrate spray around cracks, corners, behind cookers and refrigerators, and under sinks, mattresses and bed frames. Re-spray surfaces after cleaning; repeat when needed.

Dog ticks and fleas: Spray carpets and other places where these pests are found around skirting boards and cracks in walls, between cupboards, etc.

Carpet beetles and clothes moth: Spray under carpets, rugs and furniture, in cupboards, wardrobes, drawers, etc. Repeat at regular intervals.

Flies wasps and mosquitoes: Spray walls of stables and outbuildings, window and door frames, shady humid surfaces out of doors, wheelie bins and other places where flies, wasps and mosquitoes like to rest. Repeat treatment where necessary.

Bed bugs: Spray bed frames, furniture etc., paying special attention to cracks and crevices; also seams of mattresses, and any place where the bugs conceal themselves.

DANGER:

PRECAUTIONS
